For holders of diplomatic and official passports: No visas required for visits of up to 90 days.

*** Ukraine For holders of ordinary passports: No visas required for period up to 30 days, as part of two months from the date of first entrance.

For holders of diplomatic and official passports: No visas required for visits of up to 90 days.

Countries whose citizens can enter BiH with identity card.

Note: **Citizens of countries with which BiH has a visa regime, can enter BiH with a passport, without an obligation to obtain entrance, exit, transit and sojourn visas to stay on BiH territory, that is only if they have a valid reusable visa or a residence permit issued in Schengen Area countries, European Union member countries or the United States.**

Residence permit based on this is possible for 30 days.
